

# PROGRAM OVERVIEW



Transfer of ownership is a program within CTP in which an applicant transfers the rights and responsibilities for their applications to another company. An applicant typically transfers ownership of their applications if they are selling all or part of their company, merging with another company, or both.



## KEY TERMS TO ASSIST WITH THE TRANSFER OF OWNERSHIP PROCESS

### **Current Applicant**


- the entity listed as the applicant of record for the applications
- originator of the transfer request

### **New Applicant**

 the entity assuming ownership of the applications and responsibilities thereafter from the current applicant

### **Transfer of Ownership Request**

 a signed letter from an Authorized representative that contains the information for CTP to start the transfer review process

# OTHER TYPES OF REQUESTS



A transfer of ownership request **is:** 

- a submission providing adequate information for CTP to start the transfer review process
- from the current applicant of record, and clearly states the request is to transfer ownership from the current applicant of record to new applicant

A transfer of ownership request **is not** a:


- × Notification of company name change
- × Notice of bankruptcy or sale statement
- × Change in legal representation
- × Change in point of contact
- × Withdrawal Request

# TRANSFER OF OWNERSHIP PROCESS

Transfer of Ownership is important to ensure:

- accuracy of all records
- the appropriate individuals are communicating with FDA



# PROCESS FOR CURRENT APPLICANT



#### **Current Applicant**

Completes and submits a signed transfer request letter to OS from an Authorized representative that includes:



 ✓ the specific applications and products by STN to be transferred to the new applicant

 ✓ a statement that all rights of the applications have been transferred to the new applicant

✓ the name and address of the new applicant

✓ the transfer of ownership effective date



# PROCESS FOR NEW APPLICANT



#### **New Applicant**

Completes and submits a signed transfer acceptance letter to OS from an Authorized representative that includes:



 ✓ the specific applications and product names that are being accepted from current applicant
✓ a statement committing to all agreements, promises, and conditions made by current applicant of record contained in the applications

 ✓ a statement that they have a complete copy of the applications, or state they will request a copy

✓ a statement that no modifications have been made to the transferred applications

✓ the transfer of ownership effective date



# TRANSFER ACKNOWLEDGEMENT


Once the transfer of ownership request is complete, CTP has:

- updated the official records to reflect the new applicant for all applications identified in the transfer request
- issued a transfer acknowledgement letter to the new applicant with a copy to the current applicant


