OBSERVATION 1

Equipment and utensils are not cleaned at appropriate intervals to prevent contamination that would alter the safety, identity, strength, quality or purity of the drug product.

Specifically, equipment and utensils are cleaned; however, hazardous drugs were produced without providing adequate cleaning of work surfaces and utensils in that the use of a cleaning agent to inactivate any residues of hazardous drug material is not employed, which could potentially affect the safety, identity, strength, quality or purity of drug products manufactured using shared equipment.

For example, the firm produces products such as BI-EST 5.5MG/GM HRT CREAM which involves the weighing of Estradiol in a hood. The firm's current cleaning includes only the use of (b) (4)
