

MetroPCS “Win A Meet and Greet with Cain Velasquez” Sweepstakes  
Official Rules

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**OPEN TO LEGAL RESIDENTS OF ILLINOIS AGE 18+. VOID WHERE PROHIBITED.**

1. **ELIGIBILITY:** The MetroPCS “Win A Meet and Greet with Cain Velasquez” Sweepstakes (the “Sweepstakes”) is open to legal residents of Illinois age 18 or older as of the time of entry. Employees, officers and directors of MetroPCS Michigan, LLC (“Sponsor”), Zuffa, LLC, their respective parent companies, subsidiaries, affiliates, authorized dealers, advertising agencies, promotional suppliers, prize providers, and any others engaged in the development, production, or distribution of promotional materials or prizes for this Sweepstakes (collectively, “Sweepstakes Entities”), and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals, are not eligible to enter or win. Void where prohibited.

2. **HOW TO ENTER:** Visit one of the participating Chicago-area MetroPCS locations listed on Exhibit A hereto (each, a “Participating Location”) between July 7, 2015 and July 21, 2015, during that Participating Location’s regular business hours (the “Entry Period”), and complete and submit an entry form. Entry forms must be completed by hand. No photocopies accepted. Sponsor or Sponsor’s designated representative’s computer is the official timekeeping device of the Sweepstakes. The potential winner may be required to provide identification sufficient to show that he/she was the person who completed the entry form. **Limit one (1) entry per person.** All entries become the property of Sponsor and will not be returned to entrant.

3. **PRIZES AND ODDS:** There are 25 prizes, each consisting of two passes to the Cain Velasquez Meet and Greet (the “Event”) taking place between 2:00 p.m. and 4:00 p.m. on July 24, 2015, at the United Center, Chicago, IL. Each pass admits one person. The passes are not available for sale and have no retail value.

Passes are subject to terms and conditions found on pass. All other expenses on the receipt and use of a prize not specifically mentioned herein are solely the responsibility of winner, including, without limitation food and beverage, parking, souvenirs, retail purchases, taxes and gratuities. If the Event does not take place as scheduled or at all, no other prize or additional compensation shall be awarded. Any portion of prize not accepted by winner will be forfeited.

Odds of winning depend on the number of eligible entries received at all Participating Locations during the Entry Period.

4. **WINNER SELECTION AND NOTIFICATION:** All prizes will be awarded by random drawings on July 22, 2015. One prize will be awarded in each drawing. Sponsor or Sponsor's authorized representative shall conduct the drawings. Decisions of Sponsor or Sponsor's authorized representative are final and binding in all respects. **Limit one prize per household.** Sponsor will contact each apparent winner by phone at the phone number provided on the entry form. Entrants are solely responsible for the accuracy of their contact information. The apparent winners must respond no later than 5 p.m. Central Time on July 23, 2015, or prize will be forfeited. Unclaimed prizes will not be awarded. If a potential winner is found to be ineligible, or does not or cannot comply with these Official Rules, that potential winner will be disqualified and an alternate potential winner will be selected, time permitting.

The potential winners may be required to complete and return an affidavit of eligibility, a liability release and (where legal) a publicity release, which must be returned within the time period specified with such materials or Sponsor, in its sole discretion, may select an alternate potential winner, time permitting.

All federal, state, municipal and local taxes, and all expenses associated with receipt or use of a prize are the sole responsibility of winner. Winner will receive an IRS Form 1099 for the value of the prize if legally required, and will be required to provide Sponsor with winner's social security number for purposes of same.

Except as determined by Sponsor in its sole discretion, no substitution of prize is offered, no transfer of prize to a third party is permitted, and prize may not be redeemed for cash value. No difference between the stated ARV of the prize and the actual retail value will be awarded.

5. **GOVERNING LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor or the other Sweepstakes Entities in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules. Any and all disputes, claims and causes of action arising out of or in connection with this Sweepstakes or any prize awarded shall be resolved exclusively in the appropriate federal or state court located in Dallas, Texas, and entrants hereby consent and submit to the personal jurisdiction of such courts.

6. **ACCEPTABLE CONDUCT:** By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor or Sponsor's representatives, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be

in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. 7. **LIMITATIONS OF LIABILITY:** Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; or (d) any injury or damage to participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes. If, for any reason, the Sweepstakes is not capable of running as planned for reasons which may include without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. In the event of cancellation, a random drawing will be conducted to award the remaining unawarded prizes from all eligible entries received prior to cancellation. Sponsor is not responsible for typographic or printer's errors. In no event will more than the number of prizes stated in these Official Rules be awarded.

8. **RELEASES:** All entrants, as a condition of entry into the Sweepstakes, agree to release the Sweepstakes Entities from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with: submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of any prize awarded; preparing for, participating in or traveling to and/or from any prize-related activity; or any typographical or other error in these Official Rules or the announcement or offering of any prize. Each winner shall bear all risk of loss or damage to their prize after it has been delivered. Sponsor makes no representations or warranties of any kind concerning the appearance, safety or performance of any prize.
