






eSOURCE - THE CURRENT PICTURE

eSource (Electronic source) data are original patient data that are pulled digitally without having to record the data on a piece of paper first, and then transcribe it to an electronic data capture (EDC) system [1]. FDA wants to see direct use of eSource in clinical research in regulatory submissions and has published eSource Guidance in Sep 2013 followed by FR notice in June 2015.

Current practices of clinical data collection are not efficient and involves Site Coordinator (SC) capture interview questions on paper and/or transcribing data from e.g. EHR or from devices via paper route to EDC (SWIVEL CHAIR effect). The whole process is error-prone and hinders real-time analytics as access to clinical trial data by biostatistics & programming is often delayed by 6-12 weeks from the time of original collection at site.



Challenges attributing or resulting from current process, but not limited to, are:

- ✓ Duplication of Data Collection
- Unreliable internet access
- ☑ Differing metadata and data entry guidelines/requirements in EHR and EDC
- ✓ Inefficient use of EHR to identify eligible patients
- Delay in data transcription, related quality issues and extensive discrepancy management
- Significant time spent on SDV (on average 50% of monitor time)
- Lack of real-time data availability hinders effective decision making and restricts adoption of adaptive trial design


- Mobility (tablet) based direct data capture solution


