

## **KitchenAid® Stand Mixer Sweepstakes Rules**

**1. ELIGIBILITY:** KitchenAid Stand Mixer Sweepstakes is open only to legal residents of the (50) United States and the District of Columbia over the age of 18. All employees of **Everything Kitchens**, Whirlpool Corporation and all associated agencies and each of their respective affiliates, sales representatives, distributors, licensees or agents (all of the foregoing, together with Sponsor, collectively referred to as "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether related or not), are ineligible to participate in the Sweepstakes. SWEEPSTAKES ENTRY INSTRUCTIONS:** During the Sweepstakes Period, you will automatically be entered in the drawing by purchasing a KitchenAid electric product or stand mixer attachment at **Everything Kitchens**. Limit One (1) Entry per purchase, per person, per e-mail address, and per household during the Sweepstakes Period, regardless of whether a person has more than one address or more than one person uses the same address.

**4. ALTERNATIVE MEANS OF ENTRY:** You may also enter the Sweepstakes by completing the in-store form and submitting to **Everything Kitchens**. Form entries must be submitted during the Sweepstakes Period to be included within the random drawing, and no more than one form/email address may be submitted during the Sweepstakes Period. The potential winner will be notified via email to the email address or phone via the phone number submitted with the potential winner's entry within two (2) weeks after the drawing. The drawing will be conducted by **Everything Kitchens**, the judge of the Sweepstakes, whose decisions on all matters relating to the Sweepstakes shall be final and binding. In the event that a potential winner is disqualified for any reason, Sponsor may, in its sole discretion, award the applicable prize to an alternate winner selected at random. Any return of prize notification or prize email as undeliverable will result in forfeiture of any prize and an alternate winner may, at Sponsor's discretion, be randomly selected.
