Subject: **\*\*\* Updated \*\*\* Takata Recall Parts Availability Reminder**

In addition to numerous owner outreach efforts (e.g. live calls, mailers, emails, text messages), Mazda is continually sourcing and updating our Takata parts. This month, Mazda is preparing to transition Recalls 9416E, 0617A, and 2018A to a new permanent remedy inflator. There will be a two-week repair pause while old parts are collected (June 15 - June 29). On June 29<sup>th</sup>, the new recall will launch and new parts will be available for ordering. For additional detail about that process, please see the attached Dealer Email (dated June 7, 2018).

To ensure every possible repair is completed and up-to-date parts information is conveyed to our owners, we are providing this communication that outlines parts availability for Takata recalls by Model, Model Year, and Driver / Passenger Air Bag inflator. **Reminder AND Best Practice** - Always check every VIN that comes to your dealership for service (even if it is there for something as simple as a quick lube or oil change) in eMDCS for any open recalls. You may find you are a Zone B or C dealership based on location and a Zone A registered vehicle is visiting or has relocated into your area. Never assume a VINs involvement in a particular Zone and always run an eMDCS VIN inquiry.

**Subject: Transition for Passenger Air Bag Inflator Replacement - Affecting Safety Recalls 9416E, 0617A, and 2018A**

**Attention: Mazda Dealer Principal, and Service, and Parts Managers**

Please be advised Mazda is preparing to transition Recalls 9416E, 0617A, and 2018A to a new permanent remedy inflator. **The part numbers affected by this action are GLYA-57-K80 and F1Z1-57-K80.**

To prepare for the new inflator kits, parts ordering for Recalls 9416E, 0617A, and 2018A will close on Tuesday, June 12<sup>th</sup> at 5:00 PM PST, and any outstanding repairs for these recalls should be completed by Friday, June 15<sup>th</sup>.

During the weeks of June 18<sup>th</sup> to June 29<sup>th</sup> Mazda, along with the hazmat specialist, Shipmate, will work with your dealership to collect all your on hand inventory for part numbers **GLYA-57-K80 and F1Z1-57-K80.**

On June 29, 2018, Mazda will launch a new recall using the new permanent remedy replacement inflators. It is important to note the permanent remedy replacement inflator will involve a new inflator type that contains a counter-measure improvement, and will use new part numbers.

In the event you have a request to complete a customer repair during the transition, Mazda recommends usage of an MCVP loaner vehicle when available. If all MCVP vehicles are in use, or unavailable, then use your local rental facility; please offer a free rental car.

**On Friday, June 15<sup>th</sup> you will receive additional emails providing the full details of the parts collection process, including the timing to complete outstanding Warranty claims.**
