

Limited Product Warranty

Residential Air Handlers

FULL (FIVE YEAR) PARTS WARRANTY

All parts of the unit are warranted to be free from defects for five years from the date of purchase by the original consumer under normal use and when installed per Heat Controller, Inc., installation instructions and in accordance with all local, state, and national codes for normal residential use.

Transportation, handling, and labor costs to diagnose, repair or replace such defective parts are not covered by this limited parts warranty and are the owner's responsibility. Ready access to the unit for service is the responsibility of the owner.

NOTE: In the event of any required parts replacement within the period of this warranty, Heat Controller, Inc., replacement parts shall be used and will be warranted only for the period remaining on the original warranty.

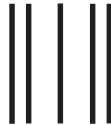
EXCEPTIONS

The warranty does not cover normal maintenance, labor charges, transportation charges for replacement parts, replacement of refrigerant or filters, any other service calls/repairs.

The warranty does not apply if:

- Unit has been subject to accident, alteration, improper repair, neglect or misuse
- Performance has been impaired by use of any product not authorized by us
- Serial numbers have been altered or removed
- Damage or failure is due to interrupted or inadequate water supply
- Damage results from improper voltages, use during brown-out conditions, circuit interruptions or inadequate power supply
- Air flow has been restricted
- Components are damaged due to freezing, erosion, scaling or use of chemicals
- Unit was purchased over the internet

DURATION OF WARRANTY/REGISTRATION CARD

The warranty begins on the date of purchase by the original consumer. The consumer must complete and return the warranty registration card and provide a receipted bill of sale as proof of warranty period. Without this proof, the warranty begins on date of shipment from the factory.

We do not warrant that the unit is suitable for any particular purpose or can be used in buildings or rooms of any particular size or condition except as specifically provided in this document. There are no other warranties, express or implied, which extend beyond the description in this document.
2. All warranties implied by law are limited in duration to the five year terms of the warranty. Your exclusive remedy is limited to the replacement of defective parts and compressor. **We will not be liable for any damages caused by any defect in this unit.**
Some states do not allow limitation on how long an implied warranty lasts or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusions may not apply to you.
3. No warranties are made for units sold outside the continental United States and Canada. Your distributor or final seller may provide a warranty on units sold outside these areas.
4. We will not be liable for delays caused by events beyond our control including accident, alternation, abuse, war, government restrictions, strikes, fire, flood, or other acts of God.

HOW TO OBTAIN WARRANTY SERVICE OR PARTS
