1 LED behaviour during regular operation

- LED behaviour: green LED when BLE command is transmitted (as long as button is pressed)
- red LED when IR command is transmitted (as long as button is pressed)

2 manual pairing

- power on STB / plug in USB dongle (in case usb dongle is used)
- press "**On Demand**" and "**Play/Pause**" keys for 3 sec to start pairing process (continues red flashing)
 - ➔ LED will stop flashing red if pairing was successful
- to delete pairing from remote control press **4** and **6** keys for 3 seconds to delete pairing
 - ➔ LED will flash 4 times red if pairing deletion was successful

3 factory settings

- to set remote control back to factory mode press **7** and **9** keys for 3 seconds
 - ➔ LED will flash 4 times

4 notes

- factory default settings: BLE mode (with rstep) and voice enabled
- pairing information will remain if batteries are being removed / changed
- mode settings will remain if batteries are being removed / changed
